

**TOWNSHIP OF FLORENCE**

**ORDINANCE 2011-08**

**An Ordinance of the Township Of Florence Amending Chapter 134 of the Florence Township Code to Establish Parking Restrictions on Portions of Winter Street and to Establish Stop Intersections at West Sixth and Winter Streets and at Tall Timber Lane**

**Whereas**, the Township Council has determined that it is necessary to designate certain portions of Winter Street as no parking areas and to designate the intersections of West Sixth at Winter Street and Tall Timber Lane at Tall Timber Lane as stop intersections in accordance with Chapter 134 of the Florence Township Code, and

**Now, Therefore, Be It Ordained** by the Township Council of the Township of Florence that:

**Section 1.** The Code of the Township of Florence is hereby amended by revising Chapter 134, Section 33, Schedule I No Parking to add the following provision:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Winter	East	From Front Street to Sixth Street.

**Section 2.** The Code of the Township of Florence is hereby amended by revising Chapter 134, Section 43, Schedule XI Stop Intersections to add the following provisions:

<b>Stop Sign On</b>	<b>At Intersection Of</b>
Sixth Street	Winter Street
Tall Timber Lane (Southbound)	Tall Timber Lane (Westbound)

**Section 3.** If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

**Section 3.** All ordinances or parts of ordinances of the Township of Florence heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**Section 4.** This ordinance shall take effect immediately upon final passage. Notice of adoption shall be published as provided by law.

The Ordinance has been adopted on first reading by the Township Council of the Township of Florence, County of Burlington, State of New Jersey, held on 7-13-11. It will be considered for final passage after public hearing to be held on 8-3-11, at 8:00 P.M. in the Municipal Complex, Council Chambers, 711 Broad Street, Florence, New Jersey.
