ORDINANCE 2012-17

**An Ordinance of the Township Of Florence
Amending Chapter 134 of the Florence Township Code
to Establish Parking Restrictions on certain roadways
in the Estates of Oak Mill Subdivision**

Whereas, the Township Council has determined that it is necessary to designate certain portions of roadways in the Estates of Oak Mill subdivision as no parking areas in accordance with Chapter 134 of the Florence Township Code, and

Whereas, the Township Engineer has reviewed and recommended the recommendations to the Township Council (See attached Exhibit B no parking restrictions).

Now, Therefore, Be It Ordained by the Township Council of the Township of Florence that:

Section 1. The Code of the Township of Florence is hereby amended by revising Chapter 134, Section 33, Schedule I No Parking to add the following provisions:

Name of Street	Side	Location
Pigott Drive	North	From Seaman Drive (West) to Seaman Drive (East)
Szypulski Lane	North	From Seaman Drive (West) to Seaman Drive (East)
West Eighth Street	Both	From Summer Street to Pigott Drive
Seaman Drive	East	Pigott Drive to West Sixth Street
Seaman Drive	West	Pigott Drive to Szypulski Lane
Seaman Drive	West	Szypulski Lane to Tetkoski Court
Seaman Drive	All	West Fifth Street to Pigott Drive
Seaman Drive	East	Pigott Drive to Szypulski Lane
Seaman Drive	East	Szypulski Drive to Tetkoski Court
Tetkoski Court	East	Seaman Drive to beginning of cul-de-sac radius

Section 2. If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

Section 3. All ordinances or parts of ordinances of the Township of Florence heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect immediately upon final passage. Notice of adoption shall be published as provided by law.
