

ORDINANCE NO. 2014 - 04

**AN ORDINANCE FIXING THE COMPENSATION OF CERTAIN
OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF FLORENCE**

BE IT ORDAINED and enacted by the Council of the Township of Florence, Burlington County, New Jersey, and it is hereby enacted and ordained by the authority of same.

The following positions and salary ranges and rates shall be payable on a weekly basis or as otherwise provided:
