

**ORDINANCE NO. 2016 - 11**

**AN ORDINANCE FIXING THE COMPENSATION OF CERTAIN OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF FLORENCE**

**BE IT ORDAINED** and enacted by the Council of the Township of Florence, Burlington County, New Jersey, and it is hereby enacted and ordained by the authority of same.
