ORDINANCE 2016-18

**An Ordinance of the Township Of Florence
Amending Chapter 134 of the Florence Township Code to
Establish Parking Restrictions on Portions of Tenth Avenue and
Ninth Avenue**

Whereas, the Township Council has determined that it is necessary to designate a certain portion of Tenth Avenue and Ninth Avenue as no parking in accordance with Chapter 134 of the Florence Township Code,

Now, Therefore, Be It Ordained by the Township Council of the Township of Florence that:

Section 1. The Code of the Township of Florence is hereby amended by revising Chapter 134, Section 33, Schedule I No Parking to add the following provision:

Name of Street	Side	Location
Tenth Avenue	Entire Cul-de-Sac	From a point measured 210 feet North of the Northern curbline of Main Street for the entire radius of the cul-de-sac on Tenth Avenue.
Ninth Avenue	Cul-de-Sac	On the East side of Ninth Avenue from a point measured 325 feet North of the Northern curbline of Main Street for the radius of the Cul-de-Sac ending at a point on the West side of Ninth Avenue as measured 290 feet North of the Northern curbline of Main Street.

Section 2. If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

Section 3. All ordinances or parts of ordinances of the Township of Florence heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

Section 4. This ordinance shall take effect immediately upon final passage. Notice of adoption shall be published as provided by law.
