WHEREAS, GovDeals will be responsible to collect on behalf of the Township of Florence the appropriate funds based on the sale of items and will remit, less the agreed upon fees, the amount due to the Township within 30 days of the sale of the items; and

WHEREAS, the terms and conditions of the township agreement with GovDeals are available on the GovDeals website and available from the Township of Florence Clerk's Office.
