We have tabulated the bids received on July 30, 2025, regarding the above-referenced project. This project consists of roadway and pedestrian improvements to Railroad Avenue, Peace Street, and Amboy Avenue summarized as follows:

• The bid consists of removal and replacement of concrete vertical curb, concrete sidewalk, and concrete driveway, replacement and/or installation of ADA compliant curb ramps, milling of existing bituminous concrete surface course, asphalt base repair, resetting or reconstruction of existing storm sewer catch basins, replacement of existing curb pieces and grates, overlay with HMA surface course, installation of signage, traffic markings, and traffic stripes, borrow topsoil, fertilizer, seed, and straw mulch.

A copy of the bid tabulation is enclosed for your review.

Our recommendation to award is as follows:

- Should the Municipality decide to award the Base Bid improvements only, the resolution should indicate award to Richard T. Barrett Paving Co., Inc., 400 Prospect Street, Trenton, New Jersey 08618, in the amount of \$309,782.70, representing Items 1 through 35 of the Base Bid.
- Should the Municipality decide to award the Base Bid & Alternate Bid No. 1 improvements, the resolution should indicate award to Richard T. Barrett Paving Co., Inc., 400 Prospect Street, Trenton, New Jersey 08618, in the amount of \$335,926.40, representing \$309,782.70 for the Base Bid and \$26,143.70 for Alternate Bid No. 1.

In accordance with Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq, the contract should be awarded to the lowest responsible bidder, which appears to be Richard T. Barrett Paving Co., Inc., 400 Prospect Street, Trenton, New Jersey 08618, in all cases. We recommend awarding the Base Bid and Alternate Bid No. 1 in the amount of \$335,926.40.
