Press Release For March 31, 2023

All municipal offices will be closed on Friday, April 7, 2023. Offices will reopen for normal business hours on Monday, April 10th.

TWICE PER WEEK TRASH COLLECTION BEGINS MONDAY, APRIL 3RD!

1. Florence Township Water and Sewer:

Florence Township Water Department routinely monitors for the presence of federal and state regulated drinking water contaminants. New Jersey adopted a standard, or MCL, for PFOA in 2020 and monitoring began in 2021. The MCL for PFOA is 0.014 parts per billion (ppb) and is based on a running annual average (RAA), in which the four most recent quarters of monitoring data are averaged. On January 12, 2023 we received notice that the sample collected in December, 2022 was 0.0078 ppb and below the regulations. Since October, 2022 the water has remained in compliance; however, because the running average (4 quarters of testing) is over the DEP limits, we are required to send out a notification letter to the residents and businesses. Florence Township has consulted with our water engineer and the DEP to develop a corrective action plan. We will continue to test the wells to ensure the safety of our residents. 7. Township Projects:

The below projects have started. We apologize for any inconvenience these projects may cause the residents and thank you for your patience.

2022 Road Program:

The 2022 Road program is 90% complete. The bike trail crossing at Broad St. will have a lighted pedestrian crossing installed. The contractor is waiting on materials. The contractor will also return in the Spring for some final clean-up and grass restoration.

9th Street:

*The 9th Street project is 90% complete and waiting on some material for the pedestrian crossing at Olive St. and Cedar St. **Please note, construction detours will be in effect as they finish the project in the coming***

days and weeks.

8. Police Department:

If you have an emergency, dial 911. If it is a non-emergency requiring police response, call (609) 267-8300. The police lobby window will be open Monday, Tuesday, Thursday & Friday from 8:00a.m. to 4:30 p.m., Wednesday 8 a.m. to 8 p.m. and Saturday 8 a.m. to 1 p.m. If you require police assistance, please use the yellow call box located by the Municipal Building Main Lobby doors. A police officer will subsequently be dispatched to handle your matter. 9. Water Service Lines Letters:

In July 2021, P.L.2021, Ch.183 (Law) was enacted, requiring all community water systems to replace lead service lines in their service area within 10 years. Under the law, Florence Township is required to notify customers, non-paying consumers, and any off-site owner of a property (e.g., landlord) when it is known or unknown, if they are served by a lead service line. A letter was sent out on 9/1/22 to those residents this new law may affect. Note that per C.58:12A-41, section 2, the definition of a lead service line now includes lead connectors (lead gooseneck, lead pigtail, or other lead fitting) and galvanized service lines. Our service line inventory is available at www.florence-nj.gov. A service line is a portion of pipe that connects the water main to the building inlet. In Florence Township, the service line is owned entirely by the property owner. The service line materials are [lead/galvanized/unknown]. Florence Township is developing a lead service line replacement program. If you are planning to replace your lead service line, contact us at (609) 499-2518 prior to replacement so that we can coordinate our efforts.

10. Municipal Offices:

For the safety of our employees and the public, we encourage individuals to wear a mask while inside the municipal building, especially if you are not feeling well. We encourage the public to continue to use the drop box located inside the front entrance to the Municipal Building for all payments, license renewals, construction permits, etc. Normal office hours are 9:00 a.m. to 4:30 p.m.

11. Township Council Meetings:

The next Council meeting is scheduled for Wednesday, April 5, 2023 starting at 7:00 p.m. Residents are encouraged to attend the meeting in-person. Office at 609-499-2525, Monday through Friday from 9:00 a.m. to 4:30 p.m. If you are unable to attend the meeting in person or virtual, you can review the zoom recording of the meeting beginning the next day by going to the township website or the link posted on our Facebook page.

12. Tax Bills & Water/Sewer Bills:

Payments can be made online www.florence-nj.gov or use the Drop Box located next to the trophy case in our front lobby. **The Drop Box will be checked multiple times daily for your convenience. Payments must be check or money orders, NO CASH.** Please provide a phone number with your payment and we will call to confirm payment was received. Please allow 48 hours for your payment to be posted to our online account portal. Feel free to call the office with any questions, 609-499-2525. The office hours are 9:00 a.m. to 4:30 p.m. Any documents left in the drop box will be processed and mailed back to residents as needed. The Drop Box is available 24/7 for resident's convenience.

13. Construction Office:

The office hours are 9:00 a.m. to 4:30 p.m. Residents and developers dropping off permits, plans, etc. are encouraged to use the drop box located inside the front entrance to the Municipal Building. Any questions, please call the Construction Office at (609) 499-2130.

14. Municipal Court:

We encourage individuals paying tickets and/or fines to continue to pay on-line or use the drop box located inside the front entrance to the Municipal Building. TESTING:

The Burlington County COVID Test Site, located in Willingboro Towne Square will be closing April 28th. Burlington County's Static COVID Vaccination Sites located on Evesham, Bordentown and the Health Dept will stop vaccinating the week of March 27th. We will transition to Friday afternoons only, from 2-4 pm, at the Health Department, 15 Pioneer Blvd, Westampton. Primary series and booster shots will be available for those 6 months and older.

To make it easier for everyone to be able to get COVID-19 test kits, the federal government is letting people order free home tests again at <https://www.covid.gov/tests> . Each household can order 4 free at-home COVID test kits. Orders should begin shipping the week of 12/19/22. Order yours today so you can test and protect your family during holiday gatherings! The Health Department is administering both Monovalent and Bivalent vaccines. Monovalent Vaccine for the Primary Series protects against severe complications from the original strain of COVID-19. The Bivalent Booster protects against severe complications resulting from infection from the original strain, as well as the BA.4 and BA.5 Omicron strains of COVID-19. The Omicron strain is the predominant strain that is currently circulating. The best protection is achieved by completing your primary series and getting your booster shot as soon as you are eligible.

VACCINES OFFERED:

- *Primary Series (Monovalent)*
- *Pfizer: 6 months – 4 years/5 – 11 years/12 years and older*
- *Moderna: 6 months – 5 years/6-11 years/12 years and older*
- *Novavax: 12 years and older*
- *Booster Shots (Bivalent)*
- *Pfizer: 6 months and older*
- *Moderna: 6 months and older*

Vaccinations for homebound individuals can be scheduled by calling the Mobile Medics at 844-569-0390 If no one answers your phone call, leave a message with your name and best contact phone number, and someone from Mobile Medics will call you to schedule your in-home appointment. The CDC has approved the administration of bivalent vaccine for children under 5. Burlington County Health Department COVID clinics are now administering the “baby bivalent” vaccines per CDC and FDA guidelines. The bivalent vaccine protects against serious complications from the original and Omicron strains of COVID-19.
