ORDINANCE 2022-10

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 134, ARTICLE II OF THE TOWNSHIP CODE OF THE TOWNSHIP OF FLORENCE TO ESTABLISH PARKING RESTRICTIONS ON PORTIONS OF HUNT CIRCUS DRIVE, JOHN GALT WAY, DANIELS WAY AND FLORENCE-COLUMBUS ROAD.

WHEREAS, the Chief of Police of the Township Police Department and Township Engineer have reviewed the impact of parking on the traffic patterns on Hunt Circus Drive, John Galt Way, Daniels Way and Florence-Columbus Road ("Roads"); and

WHEREAS, in consultation with the Township Chief of Police and Township Engineer, the Township Council has determined that it is necessary and reasonable to designate a portion of these Roads as no truck parking in accordance with Chapter 134 of the Township Code; and

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Florence in the County of Burlington, State of New Jersey as follows:

ARTICLE I: AMENDED SECTIONS. Chapter 134, Article VI, Schedule I (§134-33) is hereby amended and supplemented as follows:

In accordance with provisions of §134-3, no person shall park a vehicle at any time upon any of the following described streets or parts of streets:

Name of Street	<u>Side</u>	Location
Hunt Circus Drive	Both	From Cedar Lane to U.S. Route 130
John Galt Way	Both	From Richards Run north to the end of John Galt Way
Daniels Way	Both	From John Galt Way to the end of Daniels Way

to Old York Road

ARTICLE TWO. Repealer, Severability and Effective Date.

- 1. Repealer. Any and all other Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- 2. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.

3. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
