ORDINANCE 2022-11

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 134, ARTICLE III OF THE TOWNSHIP CODE OF THE TOWNSHIP OF FLORENCE TO DESIGNATE CROSSWALKS WITHIN FLORENCE TOWNSHIP.

WHEREAS, the Chief of Police of the Township Police Department and Township Engineer have reviewed the Township Roadways for existing crosswalks; and

WHEREAS, in consultation with the Township Chief of Police and Township Engineer, the Township Council has determined that it is necessary and reasonable to designate certain areas of the Township roadways as crosswalks; and

NOW, THEREFORE, BE IT ORDAINED by the Township Council of the Township of Florence in the County of Burlington, State of New Jersey as follows:

ARTICLE I: ADD SECTION. Chapter 134, Article III, Operation of Vehicles is hereby amended and supplemented to add §134-23.1 Crosswalks as follows:

§134-23.1 Crosswalks

The locations described in Schedule XXIV attached to and made part of this Chapter are hereby designated as crosswalks. In addition, any marked crosswalk installed in accordance with an approved site plan shall constitute a designated crosswalk whether or not it is included on Schedule XXIV, and all vehicles shall stop and yield the right-of-way to any person utilizing those crosswalks in the same manner as described in N.J.S.A. 39:4-36 and other applicable pedestrian-related statutes.

ARTICLE II: ADD SECTION. Chapter 134, Article VI, Schedules is hereby amended and supplemented to add §134-55A. Crosswalks as follows:

134-55A. Schedule XXIV: Crosswalks.

In accordance with 134-23.1, the following shall be designated crosswalk locations in Florence Township (in alphabetical order by street name):

Abrams Drive - One (1) - parallel to road, at entrance to Clubhouse

Alden Avenue - One (1) - at intersection with Hornberger Avenue

Amboy Avenue - Two (2) - (1) at intersection with Hornberger Avenue and (1) parallel to road at alley/entrance to Municipal Lot

Arnold Drive - One (1) - at intersection with Leffler Circle

Aspen Court - One (1) - at intersection with Birch Hollow Drive

Baird Drive - Two (2) - both at intersections with Spruce Street, one on either end of the loop

Barbee Court - One (1) - at intersection with Trainor Circle

Bennett Street - One (1) - at intersection with Hornberger Avenue

Birch Hollow Drive - Four (4) - (1) at first entrance to complex, closest to Birch Hollow Drive, (1) at second entrance to complex, closest to Florence-Columbus Road, and (2) at intersection with Birch Hollow Drive and Magnolia Court.

Broad Street - Fourteen (14) - (2) at Broad/Broad intersection (with one across entrance to Brookdale Assisted Living), (1) at intersection with E. Ninth Street, (1) at intersection with Wilbur Henry Drive, (1) at intersection with E. & W. Sixth Streets, (2) at intersection with E. & W. Fifth Streets, (2) at intersection with E. & W. Fourth Streets, (2) at intersection with E. & W. Third Streets, (2) at intersection with E. & W. Second Streets, (1) at intersection with E. & W. Front Streets

Broad Street alleyways, parallel to roadway - Nine (9) - (1) between E. Front and E. Second Streets, (1) between W. Front and W. Second Streets, (1) between E. Second and E. Third Streets, (1) between W. Second and W. Third Streets, (1) between W. Third and W. Fourth Streets, (1) between W. Fourth and W. Fifth Streets, (1) between E. Fifth and E. Sixth Streets, (1) between E. Sixth and Wilbur Henry Drive

Carty Drive - One (1) - at intersection with Potts Mill Road

Cedar Lane - Three (3) - (2) at intersection with Route 130, (1) at second entrance to the high school leading to the walking path

Cedar Street - Six (6) - (1) at intersection with E. Front Street, (1) at intersection with E. Third Street, (2) at intersection with E. Fifth Street, (2) parallel to roadway across entrance and exit to Riverfront School Parking Lot

Challander Way - Two (2) - (1) at intersection with Lubrano Lane, (1) at intersection with Yockus Lane Chestnut Street - Six (6) - (1) at intersection with E. Front Street, (2) at intersection with E. Second Street, (1) at intersection with E. Third Street, (2) at intersection with E. Fifth Street

Creekwood Drive - One (1) - at intersection with Potts Mill Road

Cypress Court - One (1) - at intersection with Birch Hollow Drive

D'Annunzio Lane - Two (2) - (1) at intersection with Old York Road, (1) at intersection with Ridgway Drive Daniels Way - Two (2) - (1) at intersection with John Galt Way, (1) at 250 Daniels Way

Delaware Avenue - Three (3) - (1) at intersection with Hornberger Avenue, (1) at intersection with Station Road, (1) at intersection with Route 130

- E. Eighth Street Two (2) (1) at intersection with Chestnut Street, (1) at intersection with Walnut Street
- E. Fifth Street Six (6) (1) at intersection with Broad Street, (2) at intersection with Pine Street, (2) at intersection with Cedar Street, (1) at intersection with the circle (closest to the 800 Block of E. Fifth Street)

Firehouse Lane - One (1) - at intersection with the driveway to the Florence Township Firehouse

Fourth Avenue - Five (5) - (1) at intersection with Riverside Avenue, (2) at intersection with Main Street, (2) at intersection with Hornberger Avenue

Grove Street - Two (2) - (1) at intersection with the circle (E. Fifth/Oak), (1) at intersection with Delaware Avenue Hemlock Court - One (1) - at intersection with Birch Hollow Drive

Hornberger Avenue - Twenty-two (22) - (1) at intersection with Delaware Avenue, (1) at intersection with Kinsman Road, (1) at intersection with Bennett Street, (1) at intersection with Riverbank Drive, (1) at intersection with Station Road, (1) at intersection with Parish Lane, (1) at the Riverbank Charter School of Excellence, (1) at the Roebling Elementary School, (2) parallel with the roadway across the entrance and exit to the Roebling Elementary School Parking Lot, (1) parallel to roadway across entrance to Roebling Arms, (1) at intersection with Seventh Avenue, (2) at intersection with Sixth Avenue, (2) at intersection with Fifth Avenue, (1) at intersection with Fourth Avenue, (1) at intersection with Third Avenue, (1) at intersection at Second Avenue, (1) at intersection with entrance to the NJ Transit Roebling Light rail Station, (1) parallel to roadway across entrance to the NJ Transit Roebling Light rail station, (1) at intersection with Alden Avenue

Hughes Drive - One (1) - across roadway connecting sidewalk between 2020 Route 130 warehouse and 2030 Route 130 warehouse Iron Street - Two (2) - at intersection with W. Second Street

John Galt Way - Three (3) - (1) at intersection with Route 130, (1) at intersection with Richards Run, (1) at intersection with driveway to 1000 John Galt Way Kinsman Road - One (1) - at intersection with Hornberger Avenue

Kramer Court - One (1) - across roadway connecting
sidewalk to the emergency driveway

Laurel Avenue - One (1) - at intersection with W. Front Street

Lee Lane - Two (2) - (1) at intersection with Trainor Circle, (1) at intersection with Challander Way Lubrano Lane - Four (4) - (1) at intersection with Old York Road, (2) at intersection with Ridgway Drive, (1) at intersection with Barbee Court

Lucas Court - One (1) - at intersection with Potts Mill Road

Main Street - Eleven (11) - (1) at intersection with Second Avenue, (2) at intersection with Third Avenue, (2) at intersection with Fourth Avenue, (2) at intersection with

Oak Street - Two (2) - (1) at intersection with E. Front Street, (1) at intersection with E. Third Street

Old York Road - One (1) - where the bike path crosses the roadway close to the intersection with Florence-Columbus Road

Olive Street - Two (2) - (1) at intersection with Morris Court, (1) at intersection with Applegate Drive

Parish Lane - Two (2) - (1) at intersection with Hornberger Avenue, (1) at intersection with Emerick Avenue

Pelle Court - One (1) - at intersection with Delaware Avenue

Pine Grove Lane (next to 1115 Hornberger Avenue) - One (1) - at intersection with Hornberger Avenue

Pine Street - Seven (7) - (1) at intersection with E. Front Street, (2) parallel to roadway across entrance and exit to Riverfront School Parking Lot, (2) at intersection with E. Third Street, (2) at intersection with E. Fifth Street Pond Street - One (1) - at intersection with Railroad Avenue

Potts Mill Road - One (1) - at intersection with Creekwood Drive

Railroad Avenue (700-800 Block) - One (1) - at intersection with Delaware Avenue

Railroad Avenue (10 block) - One (1) - at intersection with Hornberger Avenue

Regars Drive - Two (2) - (1) at intersection with Florence-Columbus Road, (1) at intersection with Leffler Circle Richards Run - One (1) - at intersection with John Galt Way

Ridgway Drive - Six (6) - (2) at intersection with Yockus Lane, (2) at intersection with Lubrano Lane, (1) at intersection with Trainor Circle, (1) at intersection with Barbee Court

Riverbank Drive - One (1) - at intersection with Hornberger Avenue

Riverside Avenue - Four (4) - (1) at intersection with Fourth Avenue, (1) at intersection with Fifth Avenue, (1) at intersection with Sixth Avenue, (1) across the roadway between Seventh and Eighth Avenues.

Riverside Avenue alleyway - parallel to roadway - One (1) - between Seventh and Eighth Avenues

Route 130 - Four (4) - (1) at intersection with John Galt Way, (1) at intersection with Cedar Lane, (1) at intersection with Delaware Avenue/Florence-Columbus Road, (1) at intersection with Hornberger Avenue

Seaman Drive - Two (2) - (1) at Tetkoski Court, (1) at end of walkway path near 629 Seaman Drive

Second Avenue - One (1) - at intersection with Hornberger Avenue

Spruce Street - Seven (7) - (1) at intersection with E. Front Street, (1) at intersection with E. Second Street, (2) at intersection with E. Third Street, (2) at intersection with E. Fourth Street, (1) at intersection with E. Fifth Street Station Road - Two (2) - (1) at intersection with Delaware Avenue, (1) at intersection with Hornberger Avenue

Summer Street - Five (5) - (2) at intersection with W. Second Street, (2) at intersection with W. Third Street, (1) at intersection with W. Fourth Street

Tenth Avenue - Three (3) - (2) at intersection with Main Street, (1) at intersection with Hornberger Avenue Tetkoski Court - One (1) - at intersection with Seaman

Third Avenue - Four (4) - (1) at intersection with Riverside Avenue, (2) at intersection with Main Street, (1) at intersection with Hornberger Avenue

Trainor Circle - Two (2) - both at intersections with Challander Way (with one on each end of the loop/circle)
Union Street - One (1) - at intersection with W. Second

Walnut Street - Seven (7) - (1) at intersection with E. Front Street, (2) at intersection with E. Second Street, (2) at intersection with E. Third Street, (2) at intersection with E. Fourth Street

- W. Fourth Street Two (2) (1) at intersection with Broad Street, (1) at intersection with Spring Street
- W. Front Street Five (5) (1) at intersection with Broad Street, (1) at intersection with Winter Street, (1) at intersection with Boulevard, (1) at intersection with Iron Street, (1) across roadway in the 1400 block between warehouses
- W. Second Street Nine (9) (1) at intersection with Broad Street, (2) at intersection with Spring Street, (2) at intersection with Summer Street, (1) at intersection with Eyre Street, (2) at intersection with Iron Street, (1) at intersection with Union Street
- W. Sixth Street One (1) at intersection with Broad Street
- W. Third Street Eight (8) (1) at intersection with Broad Street, (2) at intersection with Spring Street, (2) at intersection with Summer Street, (1) at intersection with Winter Street, (1) at intersection with Bodine Street, (1) at intersection with Woodlawn Avenue

Wilbur Henry Drive - One (1) - at intersection with Broad Street

Yockus Lane - Four (4) - (1) at intersection with Old York Road, (3) at intersections with Ridgway Drive (with two at the intersection closer to Old York Road and one on the other end of Yockus toward the back of the neighborhood)

ARTICLE III. Repealer, Severability and Effective Date.

1. Repealer. Any and all other Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies. 2. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Council hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.

3. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
