AN ORDINANCE OF THE TOWNSHIP OF FLORENCE, IN THE COUNTY OF BURLINGTON, NEW JERSEY, PROVIDING FOR THE CREATION AND CERTIFICATION OF A NEW TOWNSHIP TAX MAP AND GIS MAPPING OF TOWNSHIP'S STORMWATER CONVEYANCE SYSTEM AND APPROPRIATING \$325,000 TO FUND THE SAME.

BE IT ORDAINED BY THE TOWNSHIPCOUNCIL OF THE TOWNSHIPOF FLORENCE, IN THE COUNTY OF BURLINGTON, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. For the purpose of providing for the creation and certification of a new tax map for the Township in accordance with a proposal from Colliers Engineering and Design, Inc. dated December 16, 2022 and the GIS mapping of the Township's stormwater conveyance system and outfalls in accordance with a proposal from Colliers Engineering and Design, Inc. dated December 13, 2022, and including all work and materials necessary, there is hereby appropriated the sum of \$325,000 from the Township's General Capital Fund Balance.

Section 2. The capital budget or temporary capital budget (as applicable) of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

Section 3. This ordinance shall take effect as provided by Naw.
