## RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF FLORENCE, COUNTY OF BURLINGTON, NEW JERSEY CONSENTING TO THE APPOINTMENT OF AN ACTING BUSINESS ADMINISTRATOR

WHEREAS, the Township of Florence has created a position known as Business Administrator within the Township Code to perform the functions and duties set forth in Section 4-26 of the Township Code; and

WHEREAS, the appointment of the Business Administrator is at the discretion of the Mayor with the advice and consent of the Township Council; and

WHEREAS, the Mayor has the authority to fill any vacancy in the position of the Business Administrator on a temporary basis, subject to the limitations set forth in Section 4-4 of the Township Code; and

**WHEREAS**, the position of Business Administrator of the Township of Florence, in the County of Burlington, New Jersey is expected to become vacant on April 26, 2023; and

WHEREAS, the Mayor will appoint Nancy L. Erlston as acting Business Administrator as of that date: and

WHEREAS, the Township Council wishes to signify its consent to such appointment and to authorize the Acting Business Administrator to serve in this capacity until such time as a permanent Business Administrator is appointed by the Mayor and consented to by the Township Council notwithstanding the limitations set forth in Section 4-4 which would limit temporary appointments to fill a vacancy for a term not in excess of 30 days, unless the Township Council authorizes such extension;

NOW THEREFORE BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF FLORENCE that the Township Council does consent to the Mayor's appointment of Nancy L. Erlston as Acting Business Administrator effective April 26, 2023; that such appointment shall be valid until such time as a permanent Business Administrator is appointed by the Mayor and consented to by the Township Council; and that while serving as Acting Business Administrator, Nancy L. Erlston shall have all of the functions, powers and duties of the position of Business Administrator set forth in the Township Code and the statutes and regulations of the State of New Jersey; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.
