

1.	As-Built Plans	Approved water and sanitary sewer as-built plans need to be submitted. The as-built plans must be prepared by a NJ licensed land surveyor and meet the "As-Built Drawings – Minimum Requirements".
2.	Cleanouts	Adjust cleanouts to final grade once final paving has been completed.
3.	Curb Stop	Adjust curb stop to final grade once final paving has been completed.
