

Bids were received and publicly opened at the Township Building on February 27, 2024 for the "2023 CDBG Florence Township Sidewalk Improvements" project. The Notice to Bidders was advertised in the newspaper as required by law, and no addenda or clarifications were issued.

Three (3) bids were received for this project, as summarized below. A detailed bid tabulation is attached for your reference.

*Think Pavers LLC.	\$90,800.00
Engineer's Estimate	\$76,225.00

^{*}Think Pavers LLC provided a total bid amount that was incorrect due to an arithmetic error. This error can be found in red text on the bid tabulation table. The error increased the contractors bid price and therefore did not change the results of the 'low-bidder'.

By copy of this letter, we are transmitting scanned bids to the Township Attorney for review of the forms and content of the bids and bid security submitted. In accordance with the Local Public Contracts Law, contract award must be made within 60 days from the date of opening the bids.

The bid submitted by apparent low bidder Seacoast Construction Inc. is within 2.7% of the Engineer's Estimate for the project. We have worked with them in the past and found their work to be satisfactory.

Subject to the Township Attorney's review and acceptance of the proposal documentation, and the Township CFO's certification as to the availability of funds, we recommend the Township prepare the necessary Resolution of Award of Contract to Seacoast Construction Inc., for the "2023 CDBG Florence Township Sidewalk Improvements" project.

Included herewith are the original bid packages. Upon award of the contract, the bid bond provided by the unsuccessful bidders can be returned to them.
