

RESOLUTION 2024-83
EMERGENCY TEMPORARY
APPROPRIATION

WHEREAS, the total emergency temporary resolutions adopted in the year 2024 pursuant to the provisions of Chapter 96, P.L. 1951 (N.J.S.A. 40A: 4-20) including this resolution total \$374,551.00; and,

NOW, THEREFORE, BE IT RESOLVED, (by not less than two-thirds of all the members thereof affirmatively concurring) by the Governing Body of the Township of Florence, County of Burlington, State of New Jersey, that in accordance with the provisions of N.J.S.A. 40A:4-20;


