**RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP
OF FLORENCE IN THE COUNTY OF BURLINGTON NEW JERSEY
APPROVING COMPENSATION FOR BOARD MEMBERS OF THE
TOWNSHIP OF FLORENCE FIRE DISTRICT #1**

WHEREAS, N.J.S.A. 40A:14-88 provides for the establishment of compensation for boards of fire commissioners at levels approved by the board and subject to review of the governing body of the situate municipality; and

WHEREAS, on October 14, 2024, the Board of Commissioners of the Florence Township Fire District #1 adopted Resolution 2024-35 (see Schedule A attached) establishing a stipend of \$200 per month for Board members payable in quarterly installments for calendar year 2025; and


WHEREAS, the Secretary of Florence Township Fire District #1 provided a copy of Resolution 2024-35 to the Mayor and Township Council for review in accordance with N.J.S.A. 40A:14-88;

NOW THEREFORE, BE IT RESOLVED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF FLORENCE IN THE COUNTY OF BURLINGTON, NEW JERSEY that the stipend of \$200 per month for Board Members payable in quarterly installments for calendar year 2025 has been reviewed by the Township Council and has been determined to be reasonable as compensation the Board members for the duties associated with their office; and

BE IT FURTHER RESOLVED that a copy of this resolution shall be transmitted to the Board of Commissioners of Florence Township Fire District #1 for its records and for filing with the Department of Community Affairs in connection with the review and approval of the Fire District's annual budget; and

BE IT FURTHER RESOLVED that this resolution shall take effect immediately.

NOW THEREFORE BE IT RESOLVED, by the Board of Fire Commissioners, Florence Township Fire District No. 1, that:


1. That each fire commissioner is compensated 200 dollars a month for the duties associated with the office.
2. In conclusion, payments shall be made during the last payrolls of March, June, September, and December of the calendar year 2025.


BE IT FURTHER RESOLVED, that a copy of this resolution shall be placed on our Department website upon passage.
