**RESOLUTION ESTABLISHING ANNUAL SCHEDULE OF REGULAR MEETINGS
AND OTHER POLICIES RELATING TO THE NEW JERSEY
OPEN PUBLIC MEETINGS ACT**

WHEREAS, on October 21, 1975 the Legislature of the State of New Jersey enacted into Law the “Open Public Meetings Law”, P.L. 1975 c 21 (Sunshine Law) to take effect January 19, 1976 requiring that all meetings of public bodies be open to the Public at all times except under limited circumstances as specifically provided for therein; and

WHEREAS, consistent with the purpose and general requirements of the Sunshine Law, the Florence Township Planning Board now desires to give Annual Notice of the Schedule of it’s Regular Meetings to be held during the upcoming year – 2021 – and take various other actions specifically required by said Law; and

WHEREAS, consistent with such purposes, it has been determined that the newspapers named hereafter and those most likely to inform the people of the Township of Florence of any public meetings of this body, and shall herewith be designated the two newspapers to which public notices required by the Sunshine Law are to be transmitted.


NOW, THEREFORE BE IT RESOLVED by the Florence Township Planning Board at a meeting held on January 26, 2021 in the Municipal Complex, 711 Broad Street, Florence, New Jersey as follows:

1. That a schedule of meetings, dates and places attached hereto be and is hereby adopted as the official “Annual Schedule of Meetings of the “Florence Township Planning Board” for the calendar year 2021.
2. That the Burlington County Times and Trenton Times be and hereby are designated as the two newspapers which all public notices required by the Sunshine Law are to be transmitted by the Secretary.
3. That a copy of the “Annual Schedule of Meetings of the Florence Township Planning Board” be filed forthwith to the Township of Florence and posted in the main hall of the Municipal Complex.

4. That the proper officers of the Florence Township Planning Board be and hereby directed to take any and all actions that may be necessary to effect the purpose of this resolution and the Sunshine Law.
