ORDINANCE 2020-03

**An Ordinance of the Township of Florence  
Amending Chapter 134 of the Florence Township Code  
to provide for a loading zone on  
West Third Street West of Broad Street**

Whereas, the Township Council has determined that it is necessary to designate a certain Loading Zone in accordance with Chapter 134 of the Florence Township Code,

Now, Therefore, Be It Ordained by the Township Council of the Township of Florence that:

**Section 1.** The Code of the Township of Florence is hereby amended by revising Chapter 134, Section 45, Schedule XIII: Loading Zones

Name of Street	Side	Hours/Days	Location
West Third Street	North	3PM to 9PM Weekdays	Beginning at a point on the Northern curbline of West Third Street, 75 feet as measured from the Western curbline of Broad Street, then Westerly for a distance of 30 feet to a point.

**Section 2.** If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.

**Section 3.** All ordinances or parts of ordinances of the Township of Florence heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**Section 4.** This ordinance shall take effect immediately upon final passage. Notice of adoption shall be published as provided by law.
