

ORDINANCE NO. 2019 - 03

AN ORDINANCE FIXING THE COMPENSATION OF CERTAIN OFFICIALS AND EMPLOYEES OF THE TOWNSHIP OF FLORENCE

BE IT ORDAINED and enacted by the Council of the Township of Florence, Burlington County, New Jersey, and it is hereby enacted and ordained by the authority of same.
