**ORDINANCE 2018-23**

**An Ordinance of the Township of Florence  
Amending Chapter 134, Schedule XV: Bus Stops  
of the Florence Township Code**

**Whereas**, there exists conflicting interests between private property owners fronting on Hornberger Avenue and patrons of the New Jersey Transit Bus Service Route 409 which travels on Hornberger Avenue, and

**Whereas**, the Township Council has considered the recommendation of the Assistant Township Administrator to relocate the Eastbound bus stop location on Hornberger Avenue to a point directly opposite the Westbound bus stop near Amboy Avenue, and

**Whereas**, such a move allows for safer maneuvering of the public transit bus farther out of the lane of travel and permits patrons to stand-in-wait for the bus away from the front of nearby residential properties.

**Now, Therefore, Be It Ordained** by the Township Council of the Township of Florence that:

**Section 1.** The Code of the Township of Florence is hereby amended by revising Chapter 134, Section 47, Schedule XV Bus Stops for the existing bus stop at Hornberger Avenue – South – Norman Avenue to read as follows:

<b>Name of Street</b>	<b>Side</b>	<b>Location</b>
Hornberger Avenue	South	Beginning 80 feet east from the eastern curbline of Norman Avenue and extending 105 feet easterly therefrom.

**Section 2.** If any section, paragraph, subsection, clause or provision of this Ordinance shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of this Ordinance as a whole or any part thereof.


**Section 3.** All ordinances or parts of ordinances of the Township of Florence heretofore adopted that are inconsistent with any of the terms and provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**Section 4.** This ordinance shall take effect immediately upon final passage. Notice of adoption shall be published as provided by law.
