**AWARD FIVE YEAR TRASH CONTRACT
TO EXCLUSIVE SERVICE & MAINTENANCE CO. LLC**

WHEREAS, on September 5, 2018 the Township of Florence accepted bids for the collection and removal of solid waste; and

WHEREAS, there was one (1) bid received on this date and the tabulation sheets are attached; and

WHEREAS, the low bidder for base service under the current split service schedule described as Option 3A in the bid specifications is Exclusive Service & Maintenance Co. LLC d/b/a State Removal Company, 1961 Jacksonville Road, Springfield, NJ 08022; and

WHEREAS, the Township Administrator and Township Solicitor have reviewed the bids and Exclusive Service & Maintenance Co., LLC is the lowest responsible bidder for the service level desired and described herein; and

WHEREAS, it is the intention of the Township of Florence to award a five (5) year contract to Exclusive Maintenance & Service Co. LLC d/b/a Garden State Removal Company effective on December 1, 2018 for the base service locations described in the bid specifications under Option 3A; and

WHEREAS, the effective term of the contract will run for a full five (5) years from the actual start of service, and said term will be defined in writing for the record and placed in the contract file.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Council of the Township of Florence County of Burlington, New Jersey, that a five *year contract* for solid waste collection services as described herein should be awarded to Garden State Removal in accordance with the attached bid submission.
