Waste Management Contribution**



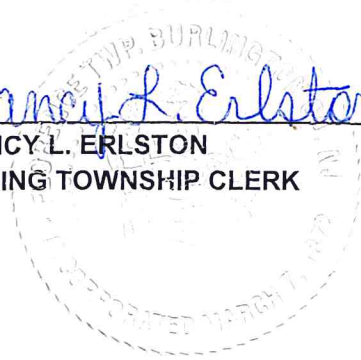

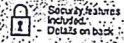
